

**PAINTED POST AREA BOARD OF TRADE  
DISTINGUISHED CITIZEN OF THE YEAR NOMINATION PACKET**

The Painted Post Area Board of Trade is organized for the purpose of advancing the commercial, industrial, civic and general interests of the Painted Post Area. The Painted Post Board of Trade established the Distinguished Citizen Award to recognize publicly those individuals who have unselfishly volunteered their time to make a significant, sustained contribution to the Painted Post area.

The criteria for selecting the Distinguished Citizen are:

- Made a significant, sustained contribution to the commercial, industrial, civic, and general interests of the Painted Post area.
- Unselfishly expended his/her time and energy in service to the community and has served in leadership positions, other than, or in addition to, his/her primary occupation, which enhanced the quality of life in the Painted Post area.
- Nominee's occupation shall not be the primary factor for recommendation to the board.
- Initiated and completed projects, which had a positive impact on the Painted Post Area.
- Has encouraged others to serve the Painted Post area by their example.
- Award can be posthumous.
- No restriction on place of residence.
- The Distinguished Citizen nominee shall have a reputation of following through the completion on the various projects, undertaken in the Community.

A special committee made up of past winners, President of the Painted Post Area Board of Trade, and other directors select the recipient from nominations solicited throughout the Painted Post area. A nomination packet is required to be completed annually for each nominee. The award will be presented at the Painted Post Area Board of Trade Annual Dinner. **Nominations are due October 23<sup>rd</sup>.** The Painted Post Board of Trade Board of Directors elects the Distinguished Citizen by secret ballot at their November meeting. A formal announcement to the community is released following the meeting.

When submitting a nomination, be certain to complete each item. Each nomination is to be accompanied by two letters of recommendation. It is encouraged that these letters be compiled and selected before the nomination package is submitted to ensure that the Painted Post Area Board of Trade receives the two letters. Remember, this includes all contributions to the Painted Post area and is not limited to just the Painted Post Area Board of Trade.

**NAME OF NOMINEE** - Full name of the nominee including their middle initial. Also include the name that the nominee prefers to be addressed by (e.g. James prefers to be called Jim).

**ADDRESS OF NOMINEE** - Residential address and mailing address if different.

**CURRENT VOLUNTEER ACTIVITIES** - List all current volunteer activities, associations, boards, and positions that the nominee is presently involved in.

**PAST VOLUNTEER ACTIVITIES** - List all past volunteer activities, associations, boards, and positions that the nominee has served or participated in prior to this nomination but no longer is presently active in (No limit, go as far back as possible).

**SPECIFIC LEADERSHIP ROLES** - Describe the nominee's leadership roles and the accomplishments, which occurred under his/her leadership. Describe how projects were initiated and completed by the nominee.

**CONTRIBUTIONS TO THE COMMERCIAL, INDUSTRIAL, CIVIC AND GENERAL INTERESTS OF THE PAINTED POST AREA** - Describe how the volunteer activities and leadership of the nominee have enhanced the commercial, industrial, civic and general interests of the Painted Post area and the impact of these activities on the Painted Post area.

**QUALITY OF LIFE** - Describe how the nominee's volunteer activities and leadership have enhanced the quality of life in the Painted Post Area.

**ENCOURAGEMENT OF SERVICE TO THE COMMUNITY** - Show how the nominee has encouraged others to serve the Painted Post area by virtue of the nominee's example.

**ADDITIONAL COMMENTS** - Any additional remarks that show the overall character of the nominee to include activities where the nominee has shown creativity and or been an inspiration to accomplish objectives; family; professional accomplishments; etc.

**SPONSOR INFORMATION** - Name, address, and phone (work and home) number including area code of the person, group or organization sponsoring the nomination of the individual.

**TWO (2) LETTERS OF RECOMMENDATION** - Attach two letters of recommendation for the nominee. Such letters may be written by the individual completing the nomination form as well as anyone who can identify the contributions of the nominee to the Painted Post area, regardless of the residence of the individual writing the recommendation.
